LIABILITY FOR SCHOOL FEES

All signatories to the enrolment Offer & Acceptance are liable for the payment of fees and levies. Any change in circumstances must be communicated to the School and new forms signed and accepted by the School. Fees are charged on enrolment not attendance.

METHODS FOR PAYMENT OF SCHOOL FEES:

All families are required to complete a Family Payment Contract each year to indicate their selected payment method:
Method 1: Pay annual fees in full by 31st January 2026, and receive a discount on tuition fees
Method 2: Pay fees by direct debit instalments throughout the year by authorising GHSS to debit your account.

NON PAYMENT OF SCHOOL FEES

Fees become overdue if:

- They have not been paid in full by Friday 31st January 2026; or
- A Fee Contract / Direct debit authority has not been returned to the school by 6th February 2026.

The School reserves the right to refer Overdue Fees to its Debt Collection Agency. Any and all costs incurred in this process will be at the expense of the debtor.

The School reserves the right to suspend or terminate enrolment of students whose fees are not up to date or in accordance with your Payment Plan.

LEAVE OF ABSENCE

There will be no reduction of fees for optional leave of absence.

DEPARTURE FROM THE SCHOOL

A Notification of Student Withdrawal Form must be submitted by no later than Day 1 of the term preceding the term you intend to leave. Failure to notify in this time will result in full term fees being charged for the following term.

Where a student leaves mid-way through term, fees for the remainder of that term are payable as well as the following term.

Should a child be suspended or expelled from school the current terms fees remain payable.

Where sufficient notice of withdrawal has been given:

- a student leaving in Terms 1 or 2 will be reimbursed/re-credited 50% of Consumables Levy.
- For students leaving in Terms 3 or 4, 100% of Consumables Levy is payable. Any unspent funds from other levies may be reimbursed/re-credited.

Any unpaid fees must be paid in full by the last day of attendance.

Re-enrolment after withdrawing will only be permitted in accordance with the Enrolment Policy. Re-enrolment can only occur once full payment of all outstanding debts has been received.

ANNUAL FEE REVIEW

Fees and policies are reviewed and set annually by the School. The School reserves the right to make changes to policies regarding fees and conditions at any time.
